Garbage Cans

t has come to the Board's **⊥** attention that many of the residents in our community are putting the garbage cans out a day or two before garbage collection day. In some instances, garbage cans may be left out on the curb for three to four days at a time. We are also seeing many residents leaving the garbage cans on the side of their home on non-collection days. Per the governing documents for the community, this is not allowed. All garbage cans are to be stored out of view from the road unless they are being placed out for garbage collection. The Board has asked that all residents place their garbage containers out on the curb no earlier than 6 PM the night before collection, and they must be returned to their proper storage places by 6 PM the day of collection.

If you would like to continue to store your garbage bins outside, a solution that you may use is privacy fencing. You may find privacy fencing at your local home improvement stores. Please see an example of this fencing submitted by one of your neighbors below:

Parking Regulations

The Board would like to remind all residents regarding the parking regulations for our community. According to the Association's documents in Article VIII, Section 19: "All vehicles of any Owner must be parked in the driveway and garage of the Owner's Lot. Owner's vehicles shall not be parked on the lawns of any Lot nor Continued on page 2

shall any Owner's vehicles be parked on the streets of the Property." The Board requests that all residents follow these regulations for the safety and well being of our neighborhood. When several cars park in the street, it is difficult for emergency vehicles and waste removal trucks to get through. The Board requests your cooperation by parking in your garage or driveway. Thank you for your assistance in this important safety matter.

Pets

Many of the residents in our community are pet owners. As many of you know, owning a pet is a wonderful experience, however, having a 4-legged addition to your family also brings many responsibilities.

If you own a pet, then one of your responsibilities is picking up after your pet. When you live in a



community, you cannot just let your pet out and then close the door. Your pet must be on a leash at all times, and any pet waste MUST be

picked up and disposed of in a waste receptacle. By not leashing or picking up after your pet, you are breaking county ordinances and this may lead to county fines if reported. Thank you for your understanding and cooperation with this matter.

Curbside Collection Program and Bulk Pick Up Instructions

Inder the Orange County Curbside Collection Program, garbage, recycling, and yard waste are each picked up <u>only</u> <u>one time per week</u>. The schedule for your community is as follows:

Garbage Collection – Tuesday Yard Waste and Recycling – Wednesday

Per the documents of your community, we are asking that you please do not place these carts outside your home in view from the street on days when you do not have a scheduled pick-up. Please keep them inside your garage, behind your fence, or behind your home.

In addition, if you have any large items that need to be picked up that will not fit in the new garbage bin, please contact the County to arrange pick-up. *Do not* place bulk items in the street or in *your driveway*. You must email or the county Solid.Waste@ocfl.net (include your name, street address, contact information, and the item(s) that you want collected) or call the Solid Waste Hotline at 407-836-6601 to arrange for pickup. Large items include furniture, appliances, mattresses, automobile tires (limit 4), and rear-projection televisions. Limit large items to three cubic yards (about one small pickup truckload) per household per week.

Pool Rules

Please be advised that the pool closes at sundown every day. No unauthorized people may enter the pool after this time. Many people ask why the Association has chosen to close the pool at sundown. The answer is simple. We did NOT choose this time. The State of Florida decided this for us! Since there is not enough light per State guidelines, we must close the pool when the sun goes down.

Next, there is a list of pool rules located in the pool area. Please take a minute and review these rules. One of the most important rules is the age limit for use. If you are under the age limit, *you may NOT* use the pool without a parent or guardian being present. Accidental drowning in a swimming pool is a leading cause of death in Florida for children. Please be advised there are no lifeguards at the pool, and the maintenance personnel are *not* trained in CPR or pool safety. Failure to comply with the Pool Rules may also result in you being asked to leave the area.
